Dear Brothers and Sisters:

I am very happy to welcome all of you at the beginning of the 2024-2025 Annual Meeting of our Society, on 01/04/2024 of the Society, report of financial year ending 31/03/2025, on the behalf of the Board of Directors, We are presenting you forward.

Membership: At the end of 31 March 2024, the Society's membership was 40662. At the end of 31 March 2025, the number of members is 41646, due to the increase in report time of 2241 and decreasing 1257 members during the reporting period.

Meeting :

The Annual General Meeting of the Committee was held on 08th September 2024 and during the report 12 meetings of the Board of Directors, and 32 of the Executive Committee were held. All the resolutions have been unanimously approved and implemented accordingly.

Share Capital :

The authorized Share Capital of the credit society is 5 crore, and the recovered portion is ₹ 3,89,10,500/- at the end of 31/03/2024 during the reporting period, ₹ 110,87700.00/- has increased by 28.50% and dated 31/03/2025 The Share Capital of the Credit Society is ₹ 4,99,98,200.00/-

Deposits :

Deposits at the end of the date of 31/03/2024 to the Credit Society at ₹ 61,34,64,150.93/- were reported to increased by ₹ 21,58,76,619.11/- in the period, 35.19% and ₹ 82,93,40,770.04/- at the end of 31/03/2025. Deposit has decreased due to firm confidence in the creditor's credit society.

Advances :

By the end of 31/03/2025, the loan was left was ₹ 57,78,34,030.93/-. In the reporting period, it increased ₹19,30,37,392.65/- that is 33.41% in till 31/03/2025, the members availed a loan of ₹ 77,08,71,423.58/-. The member committee will try to ensure that more efficient loans are in the coming financial year.
